

732nd Session
Board of Examiners for Professional Engineers and Land Surveyors
July 16, 2013

The scheduled meeting of July 16, 2013 was held at the Board Office, 165 Capitol Avenue, Room 117 in the State Office Building, Hartford, Connecticut.

Anthony L D'Andrea, Chairman called the meeting to order at 9:20 am.

Motion made by (10) seconded by (5) to approve the June 2013 minutes as amended. Motion carried.

Legal Division

AA-1 Correspondence from Dick Cottingham: Re" Early taking of PE exam which will be a motion at the NCEES annual meeting. (Dist. 4)

The Board held a discussion regarding the subject of the "timing of the PE exam" that exists in the NCEES Model Law. The Board determined that having the applicant take the Principles & Practice of Engineering exam prior to the Board's approval would be acceptable. However, when an applicant applies for licensure in Connecticut, the applicant will have to meet the Board's requirements as specified in the Board's Rules & Regulations.

Motion made by (5) seconded by (9) to have Chairman D'Andrea vote in favor of this motion at the annual meeting. Motion carried.

C-Old Business

C-1 Proposed Amendments to Regulation on Examinations. (Dist. 4)

Attorney Steven Schwane presented his draft of proposed amendments to the regulations in regards to the length of time to credit exams that have been passed; and to allow an applicant to sit for the Fundamentals of Engineering and Fundamentals of Land Surveying exams prior to the Board's approval.

The Board held a discussion and agreed to change the length of credit for all passed exams to an indefinite period of time.

The Board also agreed to allow an applicant to sit for the Fundamentals of Engineering or Fundamentals of Land Surveying exams prior to applying to the Board. However, if the applicant is seeking certification or registration in Connecticut, the applicant must still meet the Board's requirements. These changes will reflect the new CBT system for Automatic Approval.

Attorney Schwane will incorporate these changes and forward another draft to the Board at their next meeting.

CC-1 Response from Pam Powell, Director of Client Services at NCEES regarding the constraints currently set in the new CBT system, for education and registration criteria if it is tied to the MLE requirements.

(Dist.4)

Ms Powell responded that the only constraints currently set in the new CBT system will be for education. She stated that you can have the examinees indicate that they have an EAC or ETAC degree and if they do not, they will be forced back to the Board for approval. The registration criteria are not tied to the MLE requirements. She also stated that a lot of Boards are moving forward with the automatic approval and having the examinees complete the state application and meet requirements for EIT certification on the back end.

D-New Business

D-1 – Proposed Amendments to Regulation 20-300-11- Changes are a response to Public Act 13-216. (Dist. 4)

Attorney Steven Schwane presented his draft of proposed amendments to the regulation 20-300-11 in response to Public Act 13-216.

The Board held a discussion in regards to the distinction of licenses: surrender versus lapsed licenses, where surrender is a positive act and a letter of agreeing not to practice engineering would be submitted to the department and can reactivate the license without penalty. Lapsed implies that no action was taken by the licensee and therefore would require certain steps and possible penalties in order to reinstate the lapsed license.

The Board also discussed if this public act is for resident as well as non-resident licensees. Assistant Attorney Huntsman stated that he will have an informal discussion regarding this issue with his office and advise Attorney Schwane.

Attorney Schwane will incorporate any new findings and continue to work on the draft.
